APPENDIX-8 NOMAD SUPPORT STRATEGY

Mersin Entegre Sağlık Hizmetleri Yatırım ve İşletme A.Ş. has awareness, that the Project activities might create direct or indirect impacts on the socio-economic environment including; resettlement, population increase and both positive and negative impacts in the local economy.

The mission of Project Company is to establish social responsibility projects such as education, culture and beneficial projects in the local impact area to improve stakeholder's quality of life and livelihood sources.

The nomad families determined as the most vulnerable group in the local impact area of the Project, in the scope of the social baseline and impact assessment studies. These families will be faced with the physical displacement impact due to rapid urbanization strategies of Toroslar Municipality. The Project Company is planning to realize the following strategies to minimize their vulnerability related with the displacement issue. These plans will be finalized with the final decision taken by the Municipality.

a) Nomad festival

Nomad families have been organizing traditional festival in their summer squatters Arslanköy for five years. SPV is planning to give support to this organization to attract the traditional tourism.

b) Job opportunities

Four household head of seven families have job expectation from the Municipality and SPV. The Project will be a major employer in the area both construction and operation phases. Opportunities for local people are most likely to be for non-medical staff positions. The construction workers are likely to be sourced from the local area SPV will also require workers for nonmedical positions. SPV is planning to give priority to nomad families for unskilled positions both for the construction and operation phases.

c) Purchase Sheepfolds of Nomads

Nomad families has total of 1000 animals and five household head of the seven nomad families offered the Municipality and SPV to purchase their animals since they would like to start settled life and they have job expectation. SPV is planning to support these nomad families with buying their animals during the sacrifice holiday.

d) Educational Support

Social baseline studies shows that the education is one of the major problems of nomads, especially elderly woman of community are illiterate. Twenty-two percent of the community never attended the school and thirty-six percent of the community are primary school

graduated. These figures are lower, when it compared with the average education level of Turkey. Education is a major tool for the nomads while undergoing the integration process to the society.

During the social baseline studies five students have been determined. The table below represents general information about these students.
